#### COUNTY OFFICIALS SALARY - 1985-86

The 94th General Assembly enacted the County Officials Salary Bill (SB351/HB55), subsequently designated Public Chapter 428, which the Attorney General opined on August 14, 1986, gives those county officials whose salaries are determined by T.C.A. 8-24-102 (maximum salary law) and T.C.A. 8-24-104 (minimum salary law) an across the board five percent (5%) salary increase effective September 1, 1985.

Following are schedules of salary increases affected by this legislation. The schedules show current annual salary, annual salary effective September 1985 and the fiscal year 1985-86 salary for budgetary purposes.

NOTE 2: If the county clerk in your county draws compensation between the mimimum and maximum rates, you should contact the clerk to determine what your minimum salary should be effective July 1, 1985.
