# Affordable Care Act: Timeline of Upcoming **Events**

The Affordable Care Act was signed into law in 2010, but the implementation of this legislation has been phased from 2010 through 2014.

The summary below provides an overview of the remaining phases of implementation.

#### Effective October 1, 2013

Open enrollment in the Health Insurance Marketplace begins

## Effective January 1, 2014:

- \* Establishment of Health Insurance Marketplace
- Fee assessments begin for not acquiring health insurance coverage if coverage is available
- \* Increasing access to Medicaid
- Tax credits to help small businesses afford health coverage
- \* Ensuring coverage for clinical trial participation
- \* Eliminating annual limits on insurance coverage
- No discrimination due to pre-existing conditions or gender
- Increasing Small Business Health Insurance Tax Credit

#### Effective January 1, 2015:

Tying quality of care provided to physician payments begins

#### New Federal I-9 Form Available

A new I-9 form has been released by U.S. Citizenship and Immigration Services (USCIS). This new form has been updated to clarify certain stipulations and information including, but not limited to:



- Employers are not allowed to specify which forms of identification are acceptable.
- \* Employers may be fined if the form is not complete.
- Newly hired employees must complete and sign Section 1 no later than the first day of employment.
- P.O. Boxes are not accepted for the employee's address.
- Providing a Social Security number is voluntary unless the employer participates in E-Verify.
- identification documents must be presented to the employer no later than the third day after beginning employment.
