CTAS congratulates the most recent graduates of the County Officials Certificate Training Program (COCTP). The fifteen participants from across the state gathered at Montgomery Bell State Park in September for Capstone, a three-day forum designed to provide an opportunity to demonstrate the administrative, leadership, and management skills gained through COCTP. County officials and their employees are invited to the session after completing 40 hours of Category A classes, 20 hours of Category B classes, and passing an exit exam on the Tennessee County Government Handbook. At the conclusion of the forum, participants are designated by the University of Tennessee as *Certified Public Administrators*.

Schedule of Reasonable Charges for Copies of Public Records

On October 1, 2008, the Office of Open Records Counsel issued its Schedule of Reasonable Charges for Copies of Public Records. Records custodians are now authorized by T.C.A. § 10-7-503(a)(7)(C)(1) to charge reasonable costs consistent with the schedule. The schedule, together with instructions for records custodians, can be found on the website of the Office of Open Records Counsel: http://www.comptroller.state.tn.us/openrecords/

Note that charges established under separate legal authority are not governed by the schedule, and are not to be added to or combined with charges authorized under the schedule. The schedule covers charges for public records when there is no separate legal authority for such charges.

NO INCREASE IN COUNTY OFFICIALS' MINIMUM COMPENSATION NEXT YEAR

Compensation for most county officials is governed by T.C.A. § 8-24-102. This law provides for an automatic increase in the minimum salary each year based on the percentage increase given to state employees for the previous fiscal year. It requires the Commissioner of Finance and Administration to certify to the Comptroller of the Treasury the average annualized increase in state employees' compensation on or before May 1 of each year. The commissioner certified on September 11, 2008, that state employees received an average increase of zero (0) percent for the fiscal year 2008-2009. This means that there will be no increase in the minimum compensation of county officials in fiscal year 2009-2010.

Chris Garkovich, former CTAS Solid Waste Consultant, died suddenly on September 17th, 2008. Chris worked with CTAS for well over a decade and assisted counties throughout the state in implementing the initial and formative stages of the 1991 Solid Waste Management Act.

Chris had a big heart and was loyal to the counties she served in Tennessee. Chris was particularly adept at securing grants and funding for counties, and was well known for her tenaciousness and capacity to describe conditions as she saw them.
